A 10,000 Foot View The Organizational Structure of S.E.E. Working Groups

Before delving into the nitty gritty of each group, we thought it might be helpful to see the general outline of our organizational structure. Our thirty working groups are arranged into three divisions,

1) Administrative

2) Engineering & Operation "E&O"

3) Finance, Accounting, & Customer Service or "FACS"

Executive committees provide oversight for the E&O and FACS Divisions. S.E.E. member companies are encouraged to assign one or more representatives to each working group. A set of officers, selected from the group's membership, offers direction and leadership through program planning, conducting meetings & roundtables and taking minutes. Officers serve a three-year term, beginning as Secretary for a year, then rotate to Vice Chairman, and finally to Chairman.



Contact Us 404-233-1188 www.TheExchange.org Some Accident Prevention Section members serve on various <u>national</u> standard committees, such as NESC, ANSI, NFPA or ASTM. These members update the Section on specific standard developments and offer recommendations on issues that affect safety or health in the industry. This participation makes it possible for S.E.E. companies to have a strong voice in



the setting of national standards for the industry. A regular feature in APS meetings are updates on the latest **OSHA and DOT regulations** and how these impact utility operations. Our "local experts" in these areas are Chuck Lane, Manager, Safety & Health and Regulatory Issues for Southern Company Services and Robin Malott, Manager, Safety of Allegheny Energy.

"Safety" has a broad range of application in a power utility. Through the use of subcommittees, the Accident Prevention Section gives attention to specific needs in the utility arena. A list of active subcommittees appears in the column at left. These groups play an important role in the meetings. In particular, we devote half-day breakouts for attendees involved in **Transmission & Distribution Safety** (wires) as well as those involved in **Generation Safety** (fossil/nuclear plants). At the Spring 2009 meeting, members decided to pursue forming a new subcommittee dedicated to **Health & Wellness**. Since health & wellness is of interest to each one of us, we will keep you updated on this group's progress and activities.

Section members are encouraged to share new safety programs, policies, rules, etc. at meetings and offer the benefit of their experience. One unique way they accomplish this is by holding an "Accident/Near Miss Review" each meeting, in which members volunteer to present a 10-15 minute report on a recent accident or incident that occurred in their company. Presentations cover details of the event



and lessons learned. These are serious sessions, sometimes involving grave injuries or even fatalities. The Review provides a real "heads up" of things to be aware of and precautions to take to avoid injury and is always one of the top-ranked parts of the program, according to evaluations.



Movies and popcorn -- perfect combination, right? Well, you haven't tried movies & scrambled eggs! On the last day of the meeting, the APS group enjoys breakfast and **Safety Video Review**. These videos, often produced by member utilities, provide motivation and even inspiration to continue to follow all safety rules and practices.

A special project of the Accident Prevention Section is its Safety Statistics re-

porting process, which culminates in an annual **Safety Awards Program**. Each member company provides the S.E.E. Staff with accident statistics each quarter. S.E.E. compiles a report and sends it back to member companies with the combined data. S.E.E. presents awards, during the Spring meeting and Annual Conference, to top performing companies that achieve the lowest employee accident incidence rate and the lowest vehicle accident frequency rate.

We could go on and on about this group, but suffice it to say that the benefit to companies that support their safety professionals on the Prevention Section extends far beyond the meeting as attendees return refreshed with new ideas, practices and tools to augment their company's safety program, making safety a way of life for all. We appreciate all they do.
